The Arena is conveniently located a short distance from I-85, I-485, and the Concord Mills Mall.

The Charlotte Hamfest is an ARRL Sanctioned Hamfest. We actively run paid advertisements for our Hamfest in regional publications, Facebook and notice pages such as the SERA Repeater Journal. We also reach out to prior attendees by emails to promote attendance.



Again this year we are providing *FREE Parking* for everyone attending the Charlotte Hamfest. Our Free parking is paid by the Charlotte Hamfest

Committee, as this bonus draws many hams back to our event over and over again.

Our prime tables sell out very quickly. We only have **161** indoor flea market tables. This year we have combined the dealer and flea market tables on both sides of the Gold Hall. We recommend you get your table order in *early*. **There are new layouts so choosing your tables is essential!** Don't be left out by delaying your order until it is too late. By working as a team, we can make the combination of our venue, advertising and support, along with your reputation for high quality products, a profitable enterprise for both of us.

Loading and Unloading: Each area of the building has its own separate doors for unloading at the back of the Gold Hall 1 and 2. No Vehicles may drive inside the building due to very limited space after all the tables are set up. There will be dollies available to use with unloading or you can bring your own dolly. We ask that you pull up by the building, unload your vehicles and then park across the drive and not next to the building. Handicap vehicles may park next to the building in designated areas - but must have visible handicap placards. If you have a large load, please contact us at vendors@charlottehamfest.org and we'll determine if we can make any accommodations.

**Electricity** will be provided if requested for \$45 per **outlet** used. Electricity can be ordered at the show office as late as Monday, March 2, 2026. You may want to bring your own extension cords; MARS can provide gaffer's tape to secure the cords to the floor.

**Security:** There will be adequate security, including one uniformed officer at the Hamfest Entrance at the Gold Hall. The Dealer area is secured and restricted Friday evening until the 8:30 am opening on Saturday. Overnight security remains in the area.

**Registration Deadlines:** On February 27, 2026, pre-registration ends. You can check with the Show Office the morning of the show to see if there are any other tables available for purchase.

All Prices include both days of the show. All people who will be working with you in the Hamfest area, including setup personnel, must have an admission ticket purchased. Please order all your tickets in advance. If you have table numbers 1 through 42, you can purchase additional tables against the wall for \$25.00 per table to be used for storage. Please note that the aisles must be maintained to the Fire Marshall's requirements.

We are using an "a la carte" approach to tables so that the options meet your specific needs. Each Dealer Table includes an undraped table and one (1) chair. Each Flea-Market Table includes an undraped table. Other items may be purchased on the <a href="https://www.charlottehamfest.org">www.charlottehamfest.org</a> website.

**Terms**: Payment *in full* with your reservation on or by January 31, 2026. Partial payments will hold your reservation until that date. Partial payment must be at least 50% of the total order.

Only Flea Market vendors will be able to pay for tables, chairs and electricity through PayPal. Just go out to <a href="https://charlottehamfest.org">https://charlottehamfest.org</a> and select Vendor tickets (PayPal) under the Vendor Information menu Item. Complete the order form and your tickets and table reservations will be mailed to you. All <a href="Dealers must send checks">Dealers must send checks</a> with their signed Agreement.

**Refunds**: Full refund up to February 15, 2026. Sorry, but absolutely **NO REFUNDS after February 15, 2026 unless the event is cancelled.** 

**Tax Man (Dealers ONLY)**: North Carolina law requires that we have on file a copy of your **NC Sales and Use Tax license**. Please attach a copy to your registration application.

**PLEASE BE ADVISED**: You must either provide a copy of this license or apply for one before you will be allowed to set up. Absolutely no one will be allowed to exhibit without it. It's the law!!!!!

EXCEPTION: Manufacturers who are only displaying items and not taking orders are exempt from purchasing a Sales and Use Tax license.

Although cell connections have improved, reliable Cell Phone connections are unpredictable for making or receiving calls from within the metal-framed Gold Hall. If you will need reliable/constant telephone service during the 2026 Charlotte Hamfest™, let us know and we will email you an Event Center order form for a dedicated (at an additional cost) phone line. The Event Center has demonstrated to us that this is a secure internet connection that is managed by Cabarrus County.

**Table Selection** When you select a location in the Gold Hall 1 or 2, please give us a  $1^{st}$ ,  $2^{nd}$  and  $3^{rd}$  choice preference for your table locations, *along with your full payment*.

We will do our best to fill your requests – but – *full payment must accompany your request.* Send your registration in **early**, so you have the best chance to get your preferred table locations.

Table assignments will be mailed to you as soon as possible after receiving your application/payment or your payment via PayPal. Please allow adequate time for processing and mailing before calling.

#### FLEA MARKET LOYALTY SPECIAL

Did you have <u>5 or more</u> tables at the 2025 Charlotte Hamfest? If so, you may reserve that same location for the 2026 Hamfest if they are available in the new layout or we will work with you on another suitable location. In order to return to your 2025 or nearby locations, we must receive your *full payment* by December 31, 2025. If you wish, a new, different or







### Overall Gold Hall Design






## GOLD HALL 1

## **TAX INFORMATION**REQUIRED BY THE STATE OF NORTH CAROLINA

North Carolina Law requires that any dealer in the Flea Market Area must have a valid North Carolina Sales and Use Tax License <u>unless</u>, you qualify for and sign a sales tax exemption certificate.

If you have a North Carolina Sales and Use Tax License, then please provide your number in the box on the Pre-registration form which is enclosed.

If you do *NOT* have a license, and should, then you must complete an application and return it to the North Carolina Department of Revenue. You will then need to sign the certification on the preregistration form indicating you have applied for your license. If you do not have an application form and need one, we will be happy to send you one by return mail or you can go to the NC Dept of Revenue Web Site and download the form. <a href="http://www.dor.state.nc.us/downloads/sales.html">http://www.dor.state.nc.us/downloads/sales.html</a>

If you are not required to have a Sales and Use Tax license, you must complete the enclosed exemption certificate indicating the reason that you are exempt.

The Charlotte Hamfest assumes no liability if you are not properly licensed, or you fail to comply with existing statutes.

NO table assignments will be made without a properly completed EXEMPTION CERTIFICATE, SALES TAX LICENSE APPLICATION, or NC SALES TAX LICENSE NUMBER.

- No 'new' computer sales allowed by Flea Market Vendors.
- No 'new' or 'bootlegged' CD ROM/DVD sales allowed.
- No '11 Meter' or 'FCC illegal' devices allowed.
- No Cap and Badge Vendors allowed by Flea Market Vendors.
- No Food sales or alcoholic beverages allowed.
- No Pornography allowed in any form or format.
- No registered sex offenders allowed on the premises.
- No Firearms or Flammables allowed on the premises.
- No active strobe lights within the Gold Hall.
- High power laser lights must be used with discretion to avoid eye and skin injuries.
- Tables may not be Sublet.
- No Smoking allowed anywhere at the Event Center.
- Everyone in the Event Center must have a valid ticket.
- No Tailgating
- No table rearranging will be allowed due to Fire Code.

<u>NOTICE:</u> Violation of the Use Policy shall result in ejection from the Event Center grounds, without recourse to refund of any kind. Local law enforcement and/or the FCC shall be informed of any illegal activities found or suspected – no exceptions!
