Priority Location booths are high traffic, high visibility locations situated in areas that are certain to give you and your exhibit the prestige and attention, and respect you deserve. These are *Premium* spots and in *very limited* quantities. Please call first for availability.

Standard Location booths offer excellent traffic flow and great visibility at a great price.

Single Booths measure 10’ x 10’ and can be rented individually or be combined to accommodate longer, larger displays.

Prices include both days of show. All booths include draped backdrop and dividers and one lettered sign per exhibitor. One 8’ draped table per 10 ‘ x 10’ booth and two chairs. Extra 8’ tables, undraped, must be ordered in advance, prices above.

Electricity will be provided if requested for \$45. Electricity can be ordered at the show office as late as Thursday, March 7, 2020 no later than 1 pm but not on Friday..

Terms: Payment *in full* with your reservation on or by January 31, 2020. Partial payments will hold your reservation until that date. If full payment is not received by January 31, 2020, returning exhibitors space locations from last year cannot be insured.

Refunds: Full refund up to January 15, 2020. Sorry, but absolutely **NO REFUNDS after January 31, 2020**

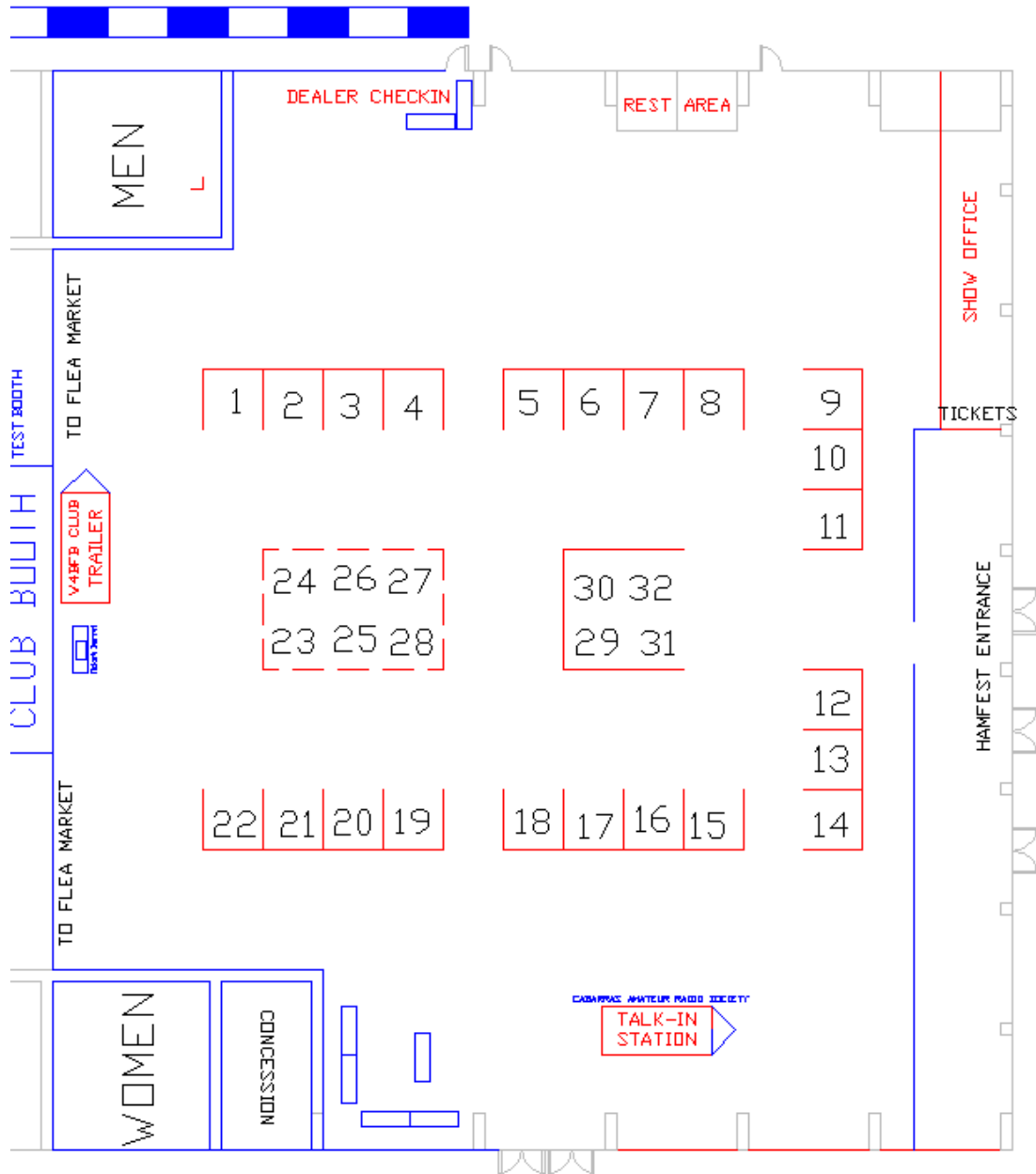

THIS AGREEMENT made by and between MECKLENBURG AMATEUR RADIO SOCIETY, INC. d/b/a CHARLOTTE HAMFEST™ (hereinafter referred to as "HAMFEST"), and _____ (hereinafter referred to as "EXHIBITOR") the day and date written below. BOOTH SPACE: In consideration for the amount paid, HAMFEST will provide and assign to the EXHIBITOR an appropriate display. Each 10' x 10" booth will be equipped with one eight foot table with coverings, two chairs, draped backdrop and dividers, lettered sign and, if ordered, 115 volt electrical service. Dedicated Telephone service must be obtained as a separate, additional fee, item NOT included in this price list.

EXHIBITOR RESPONSIBILITIES: EXHIBITOR will be solely responsible for the erection and removal of his exhibit, and for the operation of his assigned display area. All activities shall be carried out in compliance with and subject to the rules, regulations, and obligations imposed upon HAMFEST by reason of the Master Lease Agreement with the **Cabarrus Arena & Events Center**. EXHIBITOR shall be responsible for compliance with all applicable local, state, and federal regulations, including safety, licensing and/or taxing regulations, applicable to EXHIBITOR and/or the HAMFEST. EXHIBITOR agrees to indemnify and hold harmless HAMFEST, its agents, servant, employees or members from all liability that may result either directly or indirectly from any activity of EXHIBITOR. The HAMFEST reserves the right to refund booth consideration paid, and remove from the premises any EXHIBITOR found to be in material violation of any responsibility imposed under this paragraph.
